


Procurement of 'R&D Services' - Exception to procurement rules

Pre-commercial procurement

Public service contract for procurement of R&D services

in which public authority does not keep all R&D benefits exclusively to itself for internal usage in the conduct of its own affairs but shares them with external stakeholders and industry (publication, standardisation)





Pre-commercial procurement of R&D services

Excluded from WTO GPA

Excluded from Public procurement directives

- Compliant with European Union Treaty principles
 - Non-discrimination, transparency, objectivity
- Compliant with New State Aids rules
 - Procurement at market conditions



Procurement of R&D services

- Restriction to companies willing to perform significant part of R&D in EEA
- Risk-benefit sharing between procurers and suppliers
- Incentives from innovation policy agencies to public procurers

'according to market conditions'



Win-win for all

- Solves public sector innovation dilemma
 - ➤ Gets technologically innovative solutions that really address public sector needs at best price
 - 'First time' right solution
 - Shared costs, risks and benefits
 - Economies of scale
 - Increases public sector effectiveness
- Creates opportunities for local & regional suppliers






Win-win for all

- Increases European up take of R&D
 - Addresses the 'missing link in Innovation'
- Creates a European home market
 - ► Addresses market fragmentation
- Shortens the 'time to market'
 - Key in global markets such as ICT!






Reduced time to market


Lessons learned (from the US mainly)

- Right vision, right needs!
 - ➤ Anticipate future needs
- Get the 'true' buyers on board!
 - ➤ Involve procurers from start
- Don't stop on the way!
 - ➤ Go up to deployment of large scale test series (phase 3)
- Combine with venture capital for SMEs
- Remember: Innovation is a non linear process
