- ... for research data and services
- ... for research data and services
- Transparent for the researcher (all)
- Federated and trusted, global system, based on minimal, open, rigorously implemented standards and rules of participation
- Internet for data and services



- A trusted and open virtual environment for the scientific community with seamless access to services (with highest TRLs) addressing the whole research lifecycle:
 - federating core services to federate and connect existing or planned RIs
 - services to make data FAIR, store the, ensure their long-term preservation
 - services to find, access, combine, analyse and process data
 - protected, personalised work environment
- FAIR competition, no lock-in by individual service providers
- Free at point of use for the researchers
- User-oriented and inclusive (across borders and disciplines)
- Accessible through a non-exclusive, simple, universal gateway
- Governed by a minimal set of Rules of Participation
- Steered by a governance based on increasing mutuality






EOSC will provide **1.7m EU researchers** an environment with free, open services for data storage, management, analysis and re-use across disciplines

EOSC will join existing and emerging horizontal and thematic data infrastructures, bridging todays fragmentation and ad-hoc solutions

EOSC will add value and leverage past infrastructure investment (10b per year by MS, two decades EU investment)

The Vienna Declaration on the EOSC

The Vienna Declaration on the European Open Science Cloud

Vienna, 23 November 2018

We, Ministers, delegates and other participants attending the launch event of the European Open Science Cloud (EOSC):

- Recall the challenges of data driven research in pursuing excellent science as stated in the "EOSC Declaration" signed in Brussels on 10 July 2017.
- Reaffirm the potential of the European Open Science Cloud to transform the research landscape in Europe. Confirm that the vision of the European Open Science Cloud is that of a research data commons, inclusive of all disciplines and Member States, sustainable in the long-term.
- Recognise that the implementation of the European Open Science Cloud is a process, not a project, by its nature iterative and based on constant learning and mutual alignment. Highlight the need for continuous dialogue to build trust and consensus among scientists, researchers, funders, users and service providers.
- Highlight that Europe is well placed to take a global leadership position in the development and application of cloud services for Science. Reaffirm that the European Open Science Cloud will be both European and open to the world, reaching out over time to relevant global research partners.
- **Recall** that the Council in its conclusions of 29 May 2018 welcomed the implementation roadmap and the federated model for the European Open Science Cloud Univited the Commission and all Member States to set up a common governance framework that ensures participation of stakeholders from the research community based on principles of transparency, openness and inclusiveness and an effective involvement of all Member States.

The Vienna EOSC Declaration was conceived by Paolo Budroni, University of Vienna and Stefan Hanslik, Austrian Federal Ministry for Education in close cooperation with the European Commission. Vienna, 2018

The Vienna Declaration on the EOSC /2

We therefore:

- Resolve to harness the many ongoing and planned activities at EU and Member States level to cooperate in establishing an inclusive partnership with a view to developing the European Open Science Cloud as a federated infrastructure that can enhance value-based, open, trusted, user-centric digital services across borders within the Digital Single Market (DSM).
- Invite all Member States, as well as public and private stakeholders in Europe, to support actively this joint effort and the new European Open Science Cloud governance structure for a successful implementation of the initiative.
- Call for the European Open Science Cloud to provide all researchers in Europe with seamless access to an open-bydefault, efficient and cross-disciplinary environment for storing, accessing, reusing and processing research data supported by FAIR data principles.
- 10 Commit to support service provision for the European Open Science Cloud by helping connecting relevant national and disciplinary nodes to the pan-European level.
- **Reaffirm** the potential of the European Open Science Cloud to enable first-class data-driven science and to stimulate new business mode's benefiting our society and the economy. Becognise that such services will create opportunities for both public and private sectors, notably by intensifying reuse of public sector information while preserving data integrity, and ensuring access, transparency within and across borders.

We therefore declare to work together towards realising the potential of the European Open Science Cloud for the benefit of citizens, society and the economy.




Setting the scene for 2021+

Co-Creation in EOSC Secretariat...

- Setup of co-creation activities and other activities to support EOSC...
- Similar to an "Open call" approach, responsible for running the Co-creation process, under which the Co-creation budget will be utilised for participatory, project delivery, and non-foreseen activities
- Prepare the transition to new "Stakeholder-based governance"
