The alliance was constituted in October 2017 with the support of the Secretary of State of Research, Development and Innovation.

### **SOMMa Open Science Working Group**

SOMMa created an **Open Science working group** in 2018 to be able to follow its members Open Science principles application.

The **SOMMa Open Science** working group has participated in the interministerial technical **Open Science Commission** from its creation, contributing to the **National Open Science Strategy (ENCA)** for the benefit of the Spanish Research system as a whole.

**Open Science** is a global challenge, collective initiatives ensure results impacting in the system, beyond specific actors.





SOMM EXCELLENCE ALLIANCE

> As requested by EOSC Spanish representative, SOMMa ran a survey to its members. The survey was answered by 54 of its members (83% of the members at that moment) From them:

- 33 (61%) had a data management policy
- 30 (56%) referred to this policy as including open data
- 30 (56%) referred to this policy as including the principles of FAIR data
- 29 (25%) had a policy for long preservation
- 20 (37%) had a policy for open software
- 31 (57%) had an Open Science training policy
- 29 (54%) recognises open access to results in their evaluation and recognition policy





### Access to resources





40% of SOMMa members (25) are not under the umbrella of a University nor the CSIC

25 out of 62 SOMMa members do not have access to:

- transformative agreements for publications
  - direct right to use public repositories







What can SOMMa look for at EOSC?

- Map of existing infrastructures for research data management
- Infrastructure for the selection of data related professionals
- Data management training for researchers and research support professionals
